RELEASE OF LIABILITY – DOG DAY AT MEAD POOL

I understand that the act of attending, unleashing my dog(s), and/or being physically present at the Event involves the inherent risks of injury to me, other people, my dog(s), and dogs of others. I understand these risks are entirely my responsibility. I expressly assume these risks. I am aware of the risks and hazards inherent upon entering the Event and I choose to voluntarily enter Event, knowing the conditions might become more hazardous and/or dangerous for myself and/or dogs(s) and I voluntarily assume all such risks, loss, damages, or injury that may be sustained by entering the Event.

By signing this release of liability and attending the Event, I (for myself and on behalf of my heirs, executors, administrators, assigns, and personal representatives) agree to indemnify and hold harmless, the City of Appleton, its employees, agents, elected and appointed officials, and volunteers from any and all claims, suits, or actions of any kind whatsoever for any and all liability, damages, compensation or otherwise (including but not limited to attorney's fees and costs), whether present or future, known or unknown, anticipated or unanticipated, resulting from or arising out of my attendance or participation in the Event.

I also grant the City of Appleton Parks, Recreation and Facilities Management Department, their employees, and agents permission to use pictures or videos taken of me, my family, and/or my dog(s) during the participation in this event. I understand these images may be used for promotional, news, research, and/or educational purposes, including on the Internet. I understand that images posted on the Internet can be downloaded by any computer user. I waive my right to inspection or compensation, and I release, discharge, and hold harmless the above-mentioned groups and individuals from any and all claims, demands, or causes of action that I may hereafter have reason of anything contained in the photographs or video.
